The agency would ensure that all the participants would get their badges, as per their eligibility well in time.

The agency will provide badges with printing on Sun board - both sides printing (size 1.5 mm with pasting) with good quality lock and lanyard, both side printing - (photo enclosed – for categories of badges like VIP, Organizer, EC Member (around 400 nos.). The agency can visit the office between 10.00 AM to 5.00 PM on any working days to have a look/feel of the badge.
